CIRCULAR Nº 09/17 ANNUAL FEES AND TAXES FOR 2018

The values of the admission fee, annual fee and taxes for 2018 set by the General Assembly of the PGF of 12th of December of 2017 are:

1. ADMISSION FEE

(Article Nr. 10 of the Admission Rules)

1.1. Effective Members

- a) Clubs – 1.300,00 Euros
- b) Golf players – Exempt

NOTE: Clubs that result from integration with other Clubs that have been members of the PGF in the last two years (whether by merger or otherwise, even if it results in a new Club) are exempt from paying admission fee, if the registration in the PGF of new the Club so created takes place until 06.30.2018.

1.2. Institutional Members

- a) Owners and/or Managers of Golf Courses, or Associations that represent the Owners and/or Managers of the Golf Courses – 1.300,00 Euros
- b) Regional Clubs Associations – 1.300,00 Euros
- c) Coaches Associations – 1.300,00 Euros
- d) Professional Players Associations – 1.300,00 Euros
- e) Referees Associations – 1.300,00 Euros
- f) Golf Course Directors Associations – 1.300,00 Euros
- g) Greenkeepers Associations – 1.300,00 Euros

- h) Competition Organizers Institutional Members, independently of its purpose and as long as that situation is verified – 1.300,00€

2. ANNUAL FEE

(Article Nr. 10 of the Admission Rules)

2.1. Effective Member

- a) Clubs – 1.300,00 Euros
- b) Golf players
- Until 18 Years old – 6,00 Euros
 - From 19 to 24 Years old – 18,00 Euros
 - More than 24 Years old – 60,00 Euros
 - Players suffering from any kind of disability (physical or mental) medically proven and validated – 6,00 Euros

NOTE I: The annual fee for golf players registered through RIO is aggravated in 100%.

NOTE II: The golf players who join the PGF for the first time from July 1, and those not affiliated for over two years, that renew their registration from July 1, will benefit from a 50% reduction in the value of its annual fee.

2.2. Institutional Members

- a) Owners and/or Managers of Golf Courses, or Associations that represent the Owners and/or Managers of the Golf Courses – 650,00 Euros
- b) Regional Clubs Associations – Exempt
- c) Coaches Associations – Exempt
- d) Professional Players Associations – Exempt
- e) Referees Associations – Exempt
- f) Golf Course Directors Associations – Exempt
- g) Greenkeepers Associations – Exempt
- h) Competition Organizers Institutional Members, independently of its purpose and as long as that situation is verified – 650,00 Euros

3. TAXES

3.1. Sports Agents:

- a) Referees – 60,00 Euros
- b) Competition Directors – 60,00 Euros
- c) Golf Course Directors – 60,00 Euros
- d) Greenkeepers – 60,00 Euros
- e) Coaches with TPTD – 60,00 Euros

3.2. Whenever the agent is already affiliated as an individual player or professional, will be exempt from the above mentioned taxes.

For purpose of the above tables, the age of the player is calculated by the age at 31 December of the year in question.
