ADMISSION FEE AND ANNUAL FEE FOR 2025

The values of the admission fee and annual fee for 2025 are:

1. ADMISSION FEE

(Article Nr. 11 of the Admission Rules)

1.1. Effective Members

- a) Clubs – 1.500,00 Euros
- b) Golf players – Exempt

1.2. Institutional Members

- a) Owners and/or Managers of Golf Courses, or Associations that represent the Owners and/or Managers of the Golf Courses – 1.500,00 Euros
- b) Regional Clubs Associations – 1.500,00 Euros
- c) Coaches Associations – 1.500,00 Euros
- d) Professional Players Associations – 1.500,00 Euros
- e) Referees Associations – 1.500,00 Euros
- f) Golf Course Directors Associations – 1.500,00 Euros
- g) Greenkeepers Associations – 1.500,00 Euros
- h) Competition Organizers Institutional Members, independently of its purpose and as long as that situation is verified – 1.500,00€

2. ANNUAL FEE

(Article Nr. 11 of the Admission Rules)

2.1. Effective Member

- a) Clubs – 1.500,00 Euros
- b) Golf players
 - Until 18 Years old – 7,00 Euros
 - From 19 to 24 Years old – 21,00 Euros
 - More than 24 Years old – 70,00 Euros
 - Golfers with disability (according to the parameters of the European Disabled Golf Association) – 7,00 Euros

NOTE I: The annual fee for golf players registered through RIO is aggravated in 100%.

NOTE II: The golf players who join the PGF for the first time from July 1, and those not affiliated for over two years, that renew their registration from July 1, benefit from a 50% reduction in the value of its annual fee.

NOTE III: The annual fee for golf players who are also certified coaches with a valid TPTD, referees with a valid TAG, or greenkeepers registered with the Portuguese Association of Greenkeepers is reduced by 50%. The reduction mentioned in NOTE II above does not apply to these individuals.

NOTE IV: The annual fee renewed after 31st of March is aggravated in 10% over its value.

NOTE V: The age of the player is calculated by the age at 31 December of the year in question.

2.2. Institutional Members

- a) Owners and/or Managers of Golf Courses, or Associations that represent the Owners and/or Managers of the Golf Courses – 750,00 Euros
- b) Regional Clubs Associations – Exempt
- c) Coaches Associations – Exempt
- d) Professional Players Associations – Exempt
- e) Referees Associations – Exempt

- g) Greenkeepers Associations – Exempt
